TO THE AGREEMENT BETWEEN

BIONOMICS, INC. ("BIONOMICS")

AND

THE TEXAS LOW-LEVEL RADIOACTIVE WASTE DISPOSAL COMPACT COMMISSION

("COMMISSION")

SIGNED BY BIONOMICS ON JUNE 25, 2013

AND BY

THE COMMISSION ON JUNE 24, 2013

Article II.A is amended to read as follows:

A. This Agreement shall remain in effect according to its terms from June 6, 2013 to September 30, 2014 unless prior to an importation it is amended by agreement of the Parties, revoked, or suspended by the Commission. Broker agrees to provide to the Commission within 30 days after the end of each Facility operating year and after the end of the Agreement the actual cubic feet and Curies disposed of by Broker during that particular operating year or portion of a year. The Facility year ends on August 31.

Article II.J (a) Waste Volume (Cubic Feet) is amended to read as follows:

(a) Waste Volume (Cubic Feet): 90

Article II.J (c) Place of origination (State or U.S. Territory) of waste is amended to read as follows:

- (c) Place of origination (State or U.S. Territory) of waste: AL, AR, AZ, CA, CT, DC, DE, FL, GA, IL, IN, IA, KS, KY, LA, MA, MD, ME, MI, MN, MS, MO, NC, NE, NH, NJ, NY, OH, OK, PA, PR, RI, SC, SD, TN, VA, WI, WV*
- *Authorization to Import nonparty compact radioactive waste as described in this Article II.J. from any states listed is not effective until: (i) Generator has delivered to the Commission written evidence satisfactory to the Commission of the approval for the export of nonparty compact waste from the Central Interstate Low-Level Radioactive Waste Commission or the Southwestern Low-Level Radioactive Waste Commission as appropriate; and (ii) Generator has delivered to the Commission written evidence satisfactory to the Commission that it has received authorization from each generator for the disposal of the generator's waste into the Texas Low-Level Radioactive Waste Disposal Compact Facility; and (iii) Generator has received a written communication from the Commission stating the written evidence of export authorization and generator authorization is in a form satisfactory to the Commission.

TLLRWDCC-Amendment Blonomics, Inc. (TLLRWDCC #2-0032-04)

No other provision of the agreement between Blonomics and the Commission is affected by this Fourth Amendment. This Amendment is effective as of the date of its approval by the Commission on August 14, 2014.
