Waste will be incinerated at the Energy Solutions facility in Oak Ridge, Tennessee with any ash shipped to Energy Solutions burial site in Clive, Utah.

- **6. Specified Amount:** approximately 200 pounds of Dry Active Wastes (DAW)

These are Dry Solid Wastes contaminated with low levels of H-3 and C-14 generated by chemotherapeutic research involving proprietary target compounds.
