Dear Mr. McCormick,

Pursuant to the conditions expressed as part of Article II.J. (c) of your Agreement TLLRWDCC #2-0315-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission (Commission), I have received evidence satisfactory to me that you have identified in your December 7, 2021 submittal to the Commission the Generators that will have their sources disposed of at the Compact Facility in Andrews County, Texas.

Also, I have received evidence satisfactory to me that you have approval from the Southwestern Low-Level Radioactive Waste Commission and the Rocky Mountain Low-Level Radioactive Waste Board and that you do not need approval from the other compacts where the waste was generated to export low-level radioactive waste from the sites provided in your December 8, 2021 submittals to the Commission. The information provided regarding generations sources allows for very limited detail for the Commission. However, the Commission recognizes the challenges faced by RTI and Bionomics, given the long history of these sealed sources. The letter asserts your belief that the sources/waste are not of international origin. The information available is not ideal, but I believe that the assertions in the letter are reasonable and sufficient to allow the Commission to issue the CRL. This will allow the materials to be permanently disposed of and prevent any future issues associated with theft or loss of control.
