Waste which was to be disposed in the 2022 - 2023 fiscal year did not occur due to unforeseen circumstances at both the VNC Site and major changes being made concerning the General Electric company as a whole. As a part of changes being made, there is a very strong desire to dispose of the high activity Co-60 pins (75,000 Ci) and a Reactor Vessel by the end of 2023 Calendar year if possible. The attached VNC Organization Change letter to the NRC shows the designation of Mr. Carlos Martinez as being the authorized signatory for the VNC Site.
