Curie Release Letter #1

Dear Ms. Michalesko:

Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDC #2-0387-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDC"), I have received your request to dispose of irradiated hardware in the following shipment:

- The first shipment is scheduled to be shipped on or about September 11, 2023, with a disposal volume 55.7 cubic feet with approximately 10,300 curies of activity.
- The second shipment is scheduled to be shipped on or about September 21, 2023, with a disposal volume 55.7 cubic feet with approximately 9,100 curies of activity.
- The third shipment is scheduled to be shipped on or about October 5, 2023, with a disposal volume 55.7 cubic feet with approximately 11,500 curies of activity.
- The fourth shipment is scheduled to be shipped on or about October 19, 2023, with a disposal volume 55.7 cubic feet with approximately 11,500 curies of activity.
- The fifth shipment is scheduled to be shipped on or about October 27, 2023, with a disposal volume 55.7 cubic feet with approximately 10,100 curies of activity.

As of the date of this letter, there is sufficient capacity for importation during the State of Texas Fiscal Year to accommodate the shipments of an additional 52,500 curies and 279 cubic feet as requested in your letter dated August 30, 2023. This letter does not authorize the importation to the Compact Facility in Andrews County of any cubic feet or curies of low-level radioactive waste beyond the 52,500 curies and 279 cubic feet of irradiated hardware requested in the shipments..

Disposal Compact Commission

Therefore, you are authorized as of the date of your receipt of this communication to import from Tennessee Valley Authority to the Compact Facility in Andrews County, Texas 52,500 curies and 279 cubic feet of irradiated hardware described in agreement TLLRWDC #2-0387-00. These shipments are approximately 70% of the volume and 70% of the activity specified in Article II.J. of agreement TLLRWDC #2-0387-00. With this letter, Tennessee Valley Authority has remaining 121 of 400 cubic feet and 22,500 of 75,000 curies authorized to be shipped conditionally under agreement TLLRWDC #2-0387-00.

Please update the TLLRWDC as you send shipments and schedule for future shipments so we may update our tracking of imports under your agreement.
