Curie Release Letter #1


Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDC #2-0396-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDC"), I have received your request to dispose of irradiated hardware in the following shipment:

- The first shipment was scheduled to be shipped on or about August 28, 2023, with a disposal volume of 720 cubic feet with approximately 3 curies of activity.
- The second shipment is scheduled to be shipped on or about October 25, 2023, with a disposal volume of 70 cubic feet with approximately 8 curies of activity.
- The third shipment is scheduled to be shipped on or about October 27, 2023, with a disposal volume of 1500 cubic feet with approximately 2 curies of activity.

As of the date of this letter, there is sufficient capacity for importation during the State of Texas Fiscal Year to accommodate the shipments of an additional 13 curies and 2,290 cubic feet as requested in your letter dated October 11, 2023. This letter does not authorize the importation to the Compact Facility in Andrews County of any cubic feet or curies of low-level radioactive waste beyond the 13 curies and 2,290 cubic feet of irradiated hardware requested in the shipments..

Therefore, you are authorized as of the date of your receipt of this communication to import from ADP CR3 to the Compact Facility in Andrews County, Texas 13 curies and 2,290 cubic feet described in agreement TLLRWDC #2-0396-00. These shipments are approximately 14% of the volume and less than 1% of the activity specified in Article II.J. of agreement TLLRWDC #2-0396-00. With this letter, ADP CR3 has remaining 13,910 of 16,200 cubic feet and 19,787 of 19,800 curies authorized to be shipped conditionally under agreement TLLRWDC #2-0396-00.

Please update the TLLRWDC as you send shipments and schedule for future shipments so we may update our tracking of imports under your agreement.
