Curie Release Letter #1


Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDC #2-0451-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDC"), I have received your request to dispose of irradiated hardware in the following shipments:

- The 1st shipment is scheduled to be shipped on or about September 9, 2024, with a disposal volume of 56.25 cubic feet and approximately 11,700 curies of activity.
- The 2nd shipment is scheduled to be shipped on or about September 23, 2024, with a disposal volume of 56.25 cubic feet and approximately 5,680 curies of activity.
- The 3rd shipment is scheduled to be shipped on or about October 7, 2024, with a disposal volume of 56.25 cubic feet and approximately 10,600 curies of activity.
- The 4th shipment is scheduled to be shipped on or about October 21, 2024, with a disposal volume of 56.25 cubic feet and approximately 8,460 curies of activity.
- The 5th shipment is scheduled to be shipped on or about November 4, 2024, with a disposal volume of 56.25 cubic feet and approximately 6,140 curies of activity.
- The 6th shipment is scheduled to be shipped on or about November 18, 2024, with a disposal volume of 56.25 cubic feet and approximately 6,480 curies of activity.

As of the date of this letter, there is sufficient capacity for importation during the State of Texas Fiscal Year to accommodate the shipment of an additional 49,060 curies and 337.50 cubic feet as requested in your letter dated August 23, 2024. This letter does not authorize the importation to the Compact Facility in Andrews County of any cubic feet or curies of low-level radioactive waste beyond the 49,060 curies and 337.50 cubic feet of irradiated hardware requested in the shipments.

Therefore, you are authorized as of the date of your receipt of this communication to import from Entergy Grand Gulf Nuclear Station to the Compact Facility in Andrews County, Texas 49,060 curies and 337.50 cubic feet of irradiated hardware described in agreement TLLRWDC #2-0451-00. This shipment is approximately 73.37% of the volume and 57.72% of the activity specified in Article II.J. of agreement TLLRWDC #2-0451-00. With this letter, Entergy Grand Gulf Nuclear Station has remaining 122.5 of 460 cubic feet and 35,940 of 85,000 curies authorized to be shipped conditionally under agreement TLLRWDC #2-0451-00.

Please update the TLLRWDC as you send shipments and schedule for future shipments so we may update our tracking of imports under your agreement.
