Curie Release Letter #1

Dear Mr. Rowe:

Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDCC #2-0456-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDCC"), I have received your request to dispose of irradiated hardware in the following shipments:

- The first shipment is scheduled to be shipped on or about August 13, 2025, with a disposal volume of 56 cubic feet with approximately 12,000 curies of activity.
- The second shipment is scheduled to be shipped on or about August 19, 2025, with a disposal volume of 56 cubic feet with approximately 12,700 curies of activity.

As of the date of this letter, there is sufficient capacity for importation during the State of Texas Fiscal Year to accommodate the shipments of an additional 24,700 curies and 112 cubic feet as requested in your letter dated July 28, 2025. This letter does not authorize the importation to the Compact Facility in Andrews County of any cubic feet or curies of low-level radioactive waste beyond the 24,700 curies and 112 cubic feet requested in the shipments..

Therefore, you are authorized as of the date of your receipt of this communication to import from Tennessee Valley Authority to the Compact Facility in Andrews County, Texas 24,700 curies and 112 cubic feet described in agreement TLLRWDCC #2-0456-00. These shipments are approximately 1% of the volume and less than 33% of the activity specified in Article II.J. of agreement TLLRWDCC #2-0456-00. With this letter, Tennessee Valley Authority has remaining 288 of 400 cubic feet and 50,300 of 75,000 curies authorized to be shipped conditionally under agreement TLLRWDCC #2-0456-00.

Please update the TLLRWDCC as you send shipments and schedule for future shipments so we may update our tracking of imports under your agreement.
