In this instance, the time and expenses associated with properly processing and disposing of animal carcasses at the CWF far exceeds the cost to send a small amount for incineration at Energy Solutions' Bear Creek Processing Facility, with the resulting ashes buried at Clive, Utah.

Therefore, we are requesting an export permit for the generator's pail of animal carcasses, with an allowance for one additional pail in the upcoming 2025-2026 calendar year. The isotopes would include H-3 and I-125, and the quantity would be similarly small, with an estimated total volume of 1.36 ft³.
