Dear Mr. Reeves:

Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDCC #2-0130-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDCC"), I have received evidence satisfactory to me that you have approval from the Central Interstate Low-Level Radioactive Waste Commission to export low-level radioactive waste as described in Article II.J. of that Agreement which is in effect from July 1, 2016 through June 30, 2017.

As of the date of this letter, there is sufficient remaining annual capacity for importation during State of Texas Fiscal Year 2017 to accommodate the shipment of the 9,210 curies and 56 cubic feet set out below. This letter does not authorize the importation to the Compact Facility in Andrews County of any cubic feet or curies of low-level radioactive waste beyond the 9,210 curies and 56 cubic feet of irradiated hardware authorized below.

Therefore, you are authorized as of the date of your receipt of this communication to import from Entergy Riverbend Plant to the Compact Facility in Andrews County, Texas approximately 9,210 curies and 56 cubic feet of irradiated hardware described in your email dated September 7, 2016 as: used control rod blades, their corresponding velocity limiters, nuclear in-core instrumentation such as LPRMs, IRMs, SRMs and nuclear instrumentation dry tubes. This shipment is approximately 19.3% of the volume and 9.2% of the activity specified in Article II.J. of your Import Agreement TLLRWDCC #2-0130-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission. With this letter, Entergy Riverbend has approximately 66 of 290 cubic feet and 60,500 of 100,000 curies remaining to be shipped under agreement TLLRWDCC #2-0130-00.
