
Dear Mr. Readinger:

Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDDC #2-0137-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDDC"), I have received your request to dispose of 2 shipments occurring on June 26, 2017 and July 7, 2017. Each shipment will be 55.8 cubic feet and 15,800 curies of irradiated hardware, a total of 111.4 cubic feet and 31,600 curies.

As of the date of this letter, there is sufficient remaining annual capacity for importation during State of Texas Fiscal Year 2017 to accommodate the shipment of the 31,600 curies and 111.4 cubic feet set out below. This letter does not authorize the importation to the Compact Facility in Andrews County of any cubic feet or curies of low-level radioactive waste beyond the 31,600 curies and 111.4 cubic feet of irradiated hardware authorized below.

Therefore, you are authorized as of the date of your receipt of this communication to import from Brunswick Nuclear Plant to the Compact Facility in Andrews County, Texas approximately 31,600 curies and 111.4 cubic feet of irradiated hardware described in your email dated June 9<sup>th</sup>, 2017 as irradiated hardware.

These two shipments are approximately 44.6% of the volume and 32.6% of the activity specified in Article II.J. of your Import Agreement TLLRWDDC #2-0137-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission. With this letter, Brunswick Nuclear Plant has approximately 78.6 of 250 cubic feet and 17,400 of 60,000 curies remaining to be shipped under agreement TLLRWDDC #2-0137-00.
