
Dear Ms. Murchison:

Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDC #2-0194-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDC"), I have received your request to dispose of irradiated hardware in the following five shipments:

- 55.7 cubic feet / 9,200 Curies to be shipped September 13, 2018
- 55.7 cubic feet / 7,100 Curies to be shipped September 24, 2018
- 55.7 cubic feet / 9,100 Curies to be shipped October 3, 2018
- 55.7 cubic feet / 7,500 Curies to be shipped October 11, 2018
- 55.7 cubic feet / 8,300 Curies to be shipped October 23, 2018

As of the date of this letter, there is sufficient capacity for importation during State of Texas Fiscal Year 2018 to accommodate the shipments listed above as requested in your email dated August 29, 2018. This letter does not authorize the importation to the Compact Facility in Andrews County of any cubic feet or curies of low-level radioactive waste beyond the 41,200 curies and 278.5 cubic feet of irradiated hardware requested.

Therefore, you are authorized as of the date of your receipt of this communication to import from Talen Energy – Susquehanna to the Compact Facility in Andrews County, Texas 41,200 curies and 278.5 cubic feet of irradiated hardware described in agreement TLLRWDC #2-0181-00. This shipment is approximately 93% of the volume and 46% of the activity specified in Article II.J. of agreement TLLRWDC #2-0194-00. There are 21.5 additional cubic feet and 48,800 additional Curies to be shipped under this agreement.
