
Dear Ms. Koss:

Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDC #2-0205-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDC"), I have received your request to dispose of irradiated hardware in the following five shipments:

- On or about June 25, 2019: 60 cubic feet of waste with approx 10,500 Ci of activity
- On or about July 12, 2019: 60 cubic feet of waste with approx 13,000 Ci of activity
- On or about July 24, 2019: 60 cubic feet of waste with approx 13,500 Ci of activity
- On or about August 8, 2019: 60 cubic feet of waste with approx 14,200 Ci of activity
- On or about August 19, 2019: 60 cubic feet of waste with approx 13,500 Ci of activity

As of the date of this letter, there is sufficient capacity for importation during State of Texas Fiscal Year 2019 to accommodate the shipments listed above as requested in your email dated June 25, 2019. This letter does not authorize the importation to the Compact Facility in Andrews County of any cubic feet or curies of low-level radioactive waste beyond the 64,700 curies and 300 cubic feet of waste requested.

Therefore, you are authorized as of the date of your receipt of this communication to import from Tennessee Valley Authority, Browns Ferry Nuclear Plant to the Compact Facility in Andrews County, Texas 64,700 curies and 300 cubic feet of irradiated hardware described in agreement TLLRWDC #2-0205-00. This shipment is approximately 41% of the volume and 54% of the activity specified in Article II.J. of agreement TLLRWDC #2-0205-00. There are 430 additional cubic feet and 55,300 additional Curies to be shipped under this agreement.
