Curie Release Letter #3

Dear Mr. Readinger:

Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDC #2-0275-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDC"), I have received your request to dispose of the following shipments:


- On or about 3/05/2021: 111.4 cubic feet and approximately 7500 curies

As of the date of this letter, there is sufficient remaining capacity for importation during the State of Texas Fiscal Year 2021 to accommodate the shipment of 111.4 cubic feet with a radioactivity of approximately 7500 curies as set out above. This letter acknowledges the weather conditions in February that prohibited you from fulfilling the release terms set forth in the prior Curie Release Letter dated January 25, 2021. This letter does not authorize the importation to the Compact Facility in Andrews County of any additional cubic feet of low-level radioactive waste beyond the 111.4 cubic feet of material or a total curie content of more than 7500 curies.

Therefore, you are authorized as of the date of your receipt of this communication to import from Brunswick Nuclear Plant to the Compact Facility in Andrews County, Texas approximately 111.4 cubic feet of material with a radioactivity of no more than 7500 curies described in your email dated March 3, 2021. This shipment is approximately 4.3% of the volume specified in Article II.J. of your Import Agreement TLLRWDC #2-0275-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission. With this letter, Brunswick Nuclear Plant has approximately 63.6 of 175 cubic feet and 11,597 of 27,000

curies that may be shipped under agreement TLLRWDC #2-0275-00 if volume and curie limitations allow for such disposal.

Thank you for your cooperation in the Contingent Curie program that allows for the efficient and effective use of limited capacities at the Compact Facility in Andrews County, Texas.
